In connection with the PABA issued on 11 May 2026 regarding PPA Administrative Order No. 005-2026, attached herewith is the Memorandum from the Commercial Services Department, including Weekly Fuel Advisory No. 006-2026 on the implementation of the Fuel Surcharge Adjustment (FSA).

Kindly be advised that the applicable reference diesel fuel price for National Capital Region (NCR), based on the latest available retail fuel price data from the Department of Energy (DOE), is PHP81.90 per liter, also the applicable FSA rate under the PPA Fuel Price Adjustment Table is 7.1%.

The above FSA rate shall take effect on **16 June 2026**, and shall remain applicable until **22 June 2026**, or until superseded by the new Weekly Fuel Price Advisory.

Please be guided accordingly.

SUBJECT : Weekly Fuel Price Advisory No. 006- 2026 Re: Fuel Surcharge Adjustment (FSA) Implementation

In accordance with PPA Administrative Order No. 005-2026 on the implementation of the Fuel Surcharge Adjustment (FSA) mechanism, the CSD hereby issues the following advisory:

1. REFERENCE FUEL PRICE

The applicable diesel fuel price for the National Capital Region (NCR), based on the latest available DOE retail fuel price data, is:

PHP81.90 per liter

2. APPLICABLE FSA RATE AND EFFECTIVITY

Based on the above DOE NCR diesel fuel price reference, the applicable Fuel Surcharge Adjustment (FSA) rate under the PPA Fuel Price Adjustment Table is:

7.1 %

The above FSA rate shall take effect on **Tuesday, June 16, 2026** and shall remain applicable until **June 22, 2026** or until superseded by the next Weekly Fuel Price Advisory.

3. IMPLEMENTATION GUIDELINES

All Port Management Offices (PMOs) and port operators are hereby directed to:

- Apply only the FSA rate corresponding to the above reference fuel price;
- Implement FSA strictly in accordance with PPA AO No. 005-2026; and
- Apply **peso-level truncation (removal of centavo fractions without rounding up)** in all FSA computations.
